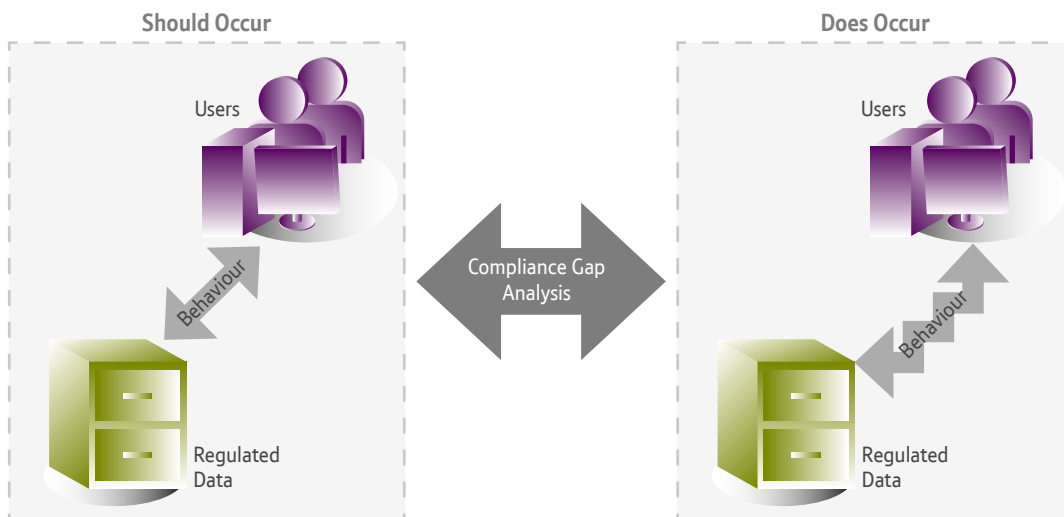
Business Challenges

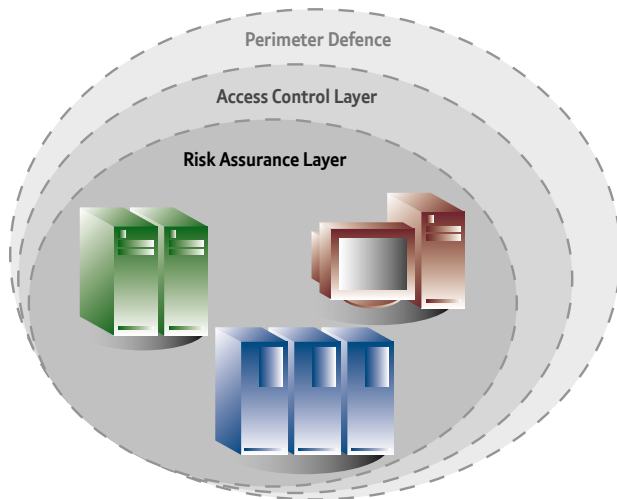
